

**Seminole Hard Rock Poker**  
POKER TOURNAMENT PLAYER OF THE YEAR LEADERBOARD PROMOTION  
OFFICIAL RULES  
September 1<sup>st</sup>, 2019 – August 31<sup>st</sup>, 2020

Players must be at least 18 years of age and a Seminole Player's Club cardholder in order to participate. Seminole Player's Club cards are free to all visitors 18 and over.

**Poker Player Eligibility**

1. Players must enter designated tournaments during the timeframe at participating Seminole casinos.
2. It is the responsibility of Seminole Players Club cardholders to have their Player's Club card properly presented to the cashier when purchasing a tournament entry and when getting paid upon cashing to receive proper credit.
3. Management will utilize Bravo application to capture player entry into events, Microsoft Excel tournament payout sheet to capture player place finished and to calculate total points based on the leaderboard formula which takes into consideration the following criteria:
  - Tournament buy-in amount
  - Player placed finished

The Seminole Hard Rock Poker Tournament Leaderboard points are fixed points and awarded as stated on file (see Exhibit A)

4. There is no limit to the number of tournament events a player may play, or the number of entries per tournament.
  - Certain tournaments may be structured offering a single entry or multiple entries.

**Prize Allocation**

1. Upon completion of the Seminole Hard Rock Tournament Leaderboard in August 2020, the final leaderboard standing will be posted and the prizes awarded as follows:
  - 1<sup>st</sup> Place
    - Entries to select Seminole Hard Rock Hollywood events
    - Entries to select Seminole Hard Rock Tampa events
    - Hotel and dining credits at Seminole Casinos
    - Total package estimated value, \$25,000
2. All prize amounts are estimated.
3. Prizes are non-transferable.
4. Prizes have no cash value.
5. All prizes must be redeemed by August 31<sup>st</sup>, 2021.

Players accumulate points by finishing in the money on designated tournaments

1. Points are based on:
  - Buy-in amount
  - Finishing position (players must cash to receive points)
2. If a deal (chop) is made, points will be awarded by chip count at the time of the deal

3. No dealing points
4. No making deal and then playing for points only
5. Results will be posted throughout the timeframe of promotion and final results will be posted on or before August 31<sup>st</sup>, 2020

### **General Rules**

1. Participants must present approved identification. They must be 18 years of age or older to participate.
2. Persons who have been trespassed or banned by the Seminole Tribe of Florida or who have opted into the self exclusion program are prohibited from participating.
3. By participating, entrants agree to be bound by these Official Rules and the decisions of Casino Management and/or the Seminole Tribal Gaming Commission.
4. Any and all applicable taxes will be final and binding on all participants.
5. Casino Management and/or the Seminole Tribal Gaming Commission will resolve any dispute or situation not covered by these rules and that decision will be final and binding on all participants.
6. Any prize receipt/voucher or drawing entry that has been mutilated, forged, misprinted, altered, tampered with, mechanically reproduced, is illegible, or has been obtained by any means other than pursuant to these rules is automatically void.
7. By participating, winners hereby give their permission to use their names, likenesses, etc., for promotional purposes without compensation.
8. Employees of Seminole Casinos and employees of vendors permanently assigned to work at a particular property and their immediate family members may not participate in any casino promotions at any of the Seminole properties. Also excluded from participating are Tour Operators, their agents and employees, as well as employees of advertising agencies, and promotional companies, their immediate family members agent's, successors and assignees.
9. These rules may be modified or cancelled by Casino Management at any time based on operational and/or business concerns.
